# Terms and Conditions

## Prize Terms and Conditions

### **1. MAJOR PRIZE - RIVERGUM HOME AT SEASONS MOUNT BARKER, FURNISHED BY TASTE FURNITURE VALUED AT \$394,950 OR \$200,000 CASH**

#### Conditions

- I. Winner of the major prize may choose to take possession of the home as displayed (including furnishings) or \$200,000 cash.

1. The TelethonSA Rivergum Home and Land Lottery at Seasons Mount Barker (Lottery) is conducted by Telethon Inc. ABN 90 546 102 726, of 118 Richmond Road, Marleston SA, 5033 (“we, us or our”)
2. These Terms and conditions are the rules which apply to the conduct of the Lottery. By purchasing a ticket or accepting a prize, each ticket holder (“you”) agrees to these terms and conditions.
3. The Lottery is conducted in South Australia under Major Lottery Licence No. M13717 issued by the Office of Business and Consumer Services.
4. The Lottery is conducted in accordance with the requirements of the Lottery and Gaming Act 1936 (SA) including the Major Lottery rules as set out in regulation 24 of the Lottery and Gaming Regulations 2008.
5. Proceeds from ticket sales from the Lottery benefit TelethonSA and the participating South Australia Charity partners.
6. Ticket sales open on Monday 26 August 2019 and close at 11:59pm Sunday 8 December 2019 (unless sold out prior).
7. Tickets purchased on or before 11:59pm on Sunday 3 November 2019 will be eligible to win the advertised Early Bird prize.
8. There are 200,000 tickets available for purchase plus up to 40,000 bonus tickets. Tickets may only be sold as single tickets at \$10 each or purchase of a book of tickets for \$50 which includes an additional bonus ticket.

  - c. From Telethon’s partners outlets as listed on the TelethonSA website.

10. TelethonSA or its participating charities may wish to contact you for future lottery or fund raising requests. There is provision on the ticket to opt-out of any such requests should you not wish to be contacted. You may also opt-out at any time following the purchase of tickets.

Each ticket holder consents to us using their personal information ONLY as necessary to comply with our obligations in relation to the Lottery and in the event that the ticket holder wins a prize, being published as set out in these terms and conditions. **This information is kept strictly confidential and NOT shared with any other organisation.**

Results will be published in the public notices section of the Adelaide Advertiser on Saturday 21 December 2019.
